



RECREATION ACCESS PROGRAM INFORMATION AND APPLICATION FORM – 2021

What is the Recreation Access Program (RAP)?

The RAP allows Squamish residents who are in financial need to access Recreation Services registered programs for 2021 at a 50% discount. Eligibility requirements, as determined by the Director of Recreation, must be met in order to qualify for RAP. Limited to two Recreation Access Program participants per program.

Eligibility

You may qualify for the Recreation Access Program if all the following requirements are met:

1. You are a resident of the District of Squamish
2. You are a Canadian citizen or permanent resident and be able to provide proof of residency
3. One of the following:
 - You receive Income Assistance from the Ministry of Social Development and Social Innovation (MSD)
 - You have a Ministry issued card or receiving disability assistance from the Province of British Columbia)
4. Your family's total income is equal to or below the amounts below.

What is a Family?

Anyone living at the same address, including all extended family members of all ages, who are related by blood, common law, adoption, or marriage, are considered to be family. The same address includes separate living areas in the same house, such as different floors of a multi-unit house or single rooms in a house.

What is total Family Income?

Total family income is the combined amount of money earned, before taxes, of all family members, in Canada and abroad, who contribute to the Squamish household. This includes employment income of all types (full and part time, reported or not reported), investments, pensions, child support payments, rental revenues, funds in trust, disability benefits, overseas income, business income and all other sources of income.

- Proof of address stating the name of one of the applicants (i.e. home utility bill dated within 3 months of application OR copy of your current lease or Residential Tenancy Agreement)
- Proof of eligibility (documents required listed above).
- If you do not have any of the requested documentation, **please call 604-898-3604 to discuss how we can help you.**

The 2021 Recreation Access Card is valid until December 31, 2021.

Once application process completed, you phone 604-898-3604 to register. Tell staff that you are approved for RAP so they know to apply the discount to your registration. Please have your application in at least two weeks before a registration start day.

RAP discounts may be revoked if misrepresented or participants do not adhere to the District's Code of Conduct or COVID safety plan.
