**Certified Copy of a Minute of the Honourable the Executive  
Council, approved by His Honour the Lieutenant-  
Governor on the 27th day of May, A.D. 1949.**

*To His Honour*

*the Lieutenant-Governor in Council:*

The undersigned has the honour to  
**report**

**THAT the Board of Commissioners of The Corporation of the Village of Squamish has requested that in order to remove an ambiguity which exists in the original definition of the boundaries of the Village, the Letters Patent of the Village be recalled and new Letters Patent be issued in its place:**

**AND TO RECOMMEND THAT pursuant to the provisions of Section 6 of the "Village Municipalities Act", the said request be granted and the Letters Patent of The Corporation of the Village of Squamish, issued on the eighteenth day of May, 1948, be recalled and Letters Patent in the form hereto attached be issued in its place:**

**AND THAT the Letters Patent be published in one issue of the Gazette:**

**AND THAT a certified copy of this Minute, if approved, be transmitted to K.M. Richardson, Acting Clerk of the said Corporation, at Squamish, B.C.**

WHEREAS under the provisions of the "Village  
Municipalities Act", The Corporation of the  
Village of Squamish, by Letters Patent under  
the Great Seal, was incorporated as a village  
municipality under date of the eighteenth day  
of May, one thousand nine hundred and forty-eight.

AND WHEREAS it is also provided in the "Village Municipalities Act" that  
the Lieutenant-Governor in Council may, by supplementary Letters Patent, from  
time to time enlarge, restrict or otherwise alter or amend the rights, powers  
and privileges, or the method of government of a village municipality incorporated  
under this Act, and may from time to time recall any Letters Patent issued under  
that Act, and may issue in its place Letters Patent varying in whole or in part  
from the Letters Patent so recalled, care being taken in every case to preserve  
all existing obligations of the village municipality:

AND WHEREAS the Board of Commissioners of The Corporation of the Village  
of Squamish has requested the Lieutenant-Governor in Council to recall the Letters  
Patent of that Corporation and issue in its place Letters Patent redefining the  
boundaries as follows: Commencing at the south-east corner of Parcel "O" of Lot  
486, Group 1, New Westminster Land District, Reference Plan No. 677, being a point  
on high-water-mark of the westerly bank of the East Branch of the Squamish River;  
thence Westerly along the southerly boundary of said Parcel "O" to the easterly  
boundary of the Pacific Great Eastern Railway Company's Right-of-Way; thence  
northerly along the said easterly boundary of the right-of-way to the northerly  
boundary of Lot 486; thence westerly along said northerly boundary of Lot 486 to  
the northerly prolongation of the easterly limit of Seventh Street, Registered  
Plan No. 3960; thence southerly along said prolongation and said easterly limit

of Seventh Street, and continuing southerly on the same straight line to high-water-mark of Howe Sound; thence in a general south-easterly direction along said high-water-mark of Howe Sound to the most southerly point of Block "I", Registered Plan 884, and continuing in a general north-easterly direction along the high-water-mark of the westerly bank of the East Branch of Squamish River to the point of commencement; All the registered plans hereinabove mentioned are on deposit in the Land Registry Office at Vancouver.

AND WHEREAS the Honourable CHARLES ARTHUR BANKS, Lieutenant-Governor of Our said Province of British Columbia, by and with the advice and consent of the Executive Council, under and by virtue of the powers and authorities conferred on him by the said Act and of all other powers and authorities him in that behalf enabling hath ordered that the Letters Patent issued on the eighteenth day of May, one thousand nine hundred and forty-eight, incorporating The Corporation of the Village of Squamish, be recalled, and that this Letters Patent be substituted in its place:

NOW KNOW YE that by these presents We do order and proclaim that the inhabitants of the area hereinbefore described shall on, from, and after the date hereof constitute the village municipality known as "The Corporation of the Village of Squamish", under and subject to the provisions of the "Village Municipalities Act", and under and subject to the provisions hereinafter contained or referred to.

1. The said municipality shall be called and known by the name and style of "The Corporation of the Village of Squamish".
2. The said municipality shall comprise all that area of land hereinbefore described.
3. The provisions contained in the Schedule to the "Village Municipalities Act" shall apply to the said municipality.
4. Nothing in this Letters Patent or in the Order of the Lieutenant-Governor in Council, shall impair or affect the rights of any creditor of The Corporation of the Village of Squamish as incorporated under the former Letters Patent, and The Corporation of the Village of Squamish as incorporated under this Letters Patent shall be liable for and subject to and shall pay, discharge, carry out, and perform all the debts, liabilities, obligations, contracts and duties of The Corporation of the Village of Squamish which are existing at the date hereof.

5. The members of the Board of Commissioners of The Corporation of the Village of Squamish who are in office at the date hereof shall continue to constitute the Board of Commissioners, and their term of office shall not be in any way affected by the recall of the former Letters Patent and the substitution of this Letters Patent.

IN TESTIMONY WHEREOF, We have caused these Our Letters to be made Patent and the Great Seal of Our said Province to be hereunto affixed.

WITNESS, the Honourable CHARLES ARTHUR BANKS, Lieutenant-Governor of Our said Province of British Columbia, in Our City of Victoria, in Our said Province, this 27th day of May in the year of our Lord one thousand nine hundred and forty-nine, and in the thirteenth year of Our Reign.
