



# Alternative Approval Elector Response Form

District of Squamish Whittaker Slough Pump Station Loan Authorization Bylaw No. 3162, 2025

I am **OPPOSED** to the District proceeding with the adoption of “**District of Squamish Whittaker Slough Pump Station Loan Authorization Bylaw No. 3162, 2025**”, the intent of which is to authorize the borrowing of up to a maximum amount of five hundred and sixty-eight thousand, and sixty dollars (\$568,060) in order to install a drainage pump station at the Whittaker Slough, acquire all such real property, easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for, or in connection with, the construction and acquisition of the said improvements.

**Only those persons who qualify as electors or non-resident property electors of the District of Squamish are entitled to sign an elector response form.**

I, the undersigned, hereby declare that:

- ✓ I am eighteen years of age or older; and
- ✓ I am a Canadian Citizen; and
- ✓ I have resided in British Columbia for at least six months; and
- ✓ I reside in, OR am a registered owner of property in the District of Squamish; and
- ✓ I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in an election/elector approval process; and
- ✓ I am entitled to sign this alternative approval process elector response form and have not previously signed an alternative approval process elector response form for the proposed Bylaw.

*\*Section 86(7) of the Community Charter requires the elector to provide their full name and residential address. In the case of a non-resident property elector each person must provide their residential address and address of the property within the District of Squamish in relation to which the person is entitled to register as a non-resident property elector. Failure to provide the required information will result in the elector response being declared invalid.*

\*Personal information is collected for the purposes of conducting the alternative approval process under the *Community Charter* and will only be used to verify the validity of the elector response form. The District is collecting this information under sections 26(a) and (c) of the *Freedom of Information and Protection of Privacy Act*. ## INSTRUCTIONS

- If you are **opposed** to the borrowing for the **Whittaker Slough Pump Station Project** and you qualify as an elector or non-resident property elector of the District of Squamish (see front page), you may sign an alternative approval process elector response form.
- If you are **NOT opposed** to the borrowing you do not need to do anything.
- Accurate copies of this elector response form may be made and used for signing.
- A person may not sign more than one elector response form.
- Only one person may sign each elector response form
- The full name and residential address must be included on the elector response form and, if applicable, also the address for the property in relation to which the person is entitled to register as a non-resident property elector.

**Signed elector response forms MUST be received by the Corporate Officer (or delegate) at Squamish Municipal Hall (37955 Second Avenue, Squamish BC) no later than 4:30 p.m. on February 16, 2026.**

*\*If you are submitting this form by mail, please note **post marks are not accepted as the date of submission**. It is the responsibility of the elector to ensure the response form is received in the Legislative Services Department by the deadline. A hand-written (physical) signature is required. Electronic signatures or any electronic submissions will not be accepted.*

## CRITERIA FOR NON-RESIDENT PROPERTY ELECTORS

A Non- Resident Property Elector **must:**

- *Not* be entitled to register as a resident elector of the District of Squamish;
- Be an individual who is age 18 or older;
- Be a Canadian citizen;
- Have been a resident of British Columbia, for at least 6 months;
- Have been a registered owner of real property in the District of Squamish for at least 30 days;
- Not be disqualified by the *Local Government Act* or any other enactment from voting in an election or be otherwise disqualified by law; AND
- a person may only register as a non-resident property elector in relation to one parcel of real property in a jurisdiction.
