GENERAL SUMMARY

Reporting to the Manager of Major Projects - Industrial, the Municipal Engineer 1 supports the Major Projects - Industrial team coordinating and completing permitting and plan reviews adhering to legislative requirements. This role is responsible for design review and field monitoring of development and infrastructure projects, as well as reviews off-site servicing requirements of development projects. The focus of this role will be on liaising with the Development Engineering team, the Planning department and Building Department on Civil Engineering aspects of development projects comprising the Major Projects - Industrial portfolio.

KEY RESPONSIBILITIES

- Contributes to the success of our team and growth of our community by fostering the District of Squamish corporate values: Respect, Integrity, Connection and Progress.
- Hires consultants to develop preliminary and feasibility plans, monitors activities to ensure design and projects satisfy all goals and objectives including being on-schedule and within budget expectations.
- Supports the Major Projects Industrial team in complex development and infrastructure projects involving Engineering, Environmental, Planning, and Public Works functions working together in a project that is developed with the best interests of present and future citizens; and that balances social, economic, and environmental priorities.
- Performs field inspections of Civil and Environmental works that pertain to development projects.
- Advises and consults with other departments, agencies, community groups, property owners, associations, clubs, and the public on development-related matters and attends public meetings as required.
- Ensures that the Division of Community Development, procedures, practices, and priorities are conducted and carried out within Council's vision for the community.
- Prepares technical reports and makes presentations as required.
- Prepares terms of reference for engineering studies and designs, calls for proposals, and evaluates and awards assignments in accordance with the District's Procurement Policy.
- Responsible for the award of work within legal guidelines and District Policy.
- Reviews design submissions for proposed developments in order to determine whether appropriate engineering standards have been met.
- Manages engineering assignments to ensure that work is completed to District standards, within budget and on schedule.
- Works with the Planning Department in review of pre-applications for Developments; provides input to OCP Amendments, Zoning, Subdivisions and Service Agreements, along with Environmental permits, such as Site Alteration Permits.
- Works with the developer's Engineering team, District Engineering and Public Works on off-site design review and approval, creating Servicing Agreements, and conducting construction review and inspections of development project infrastructure.
- Monitors District-run projects, including project management, contract administration, and inspections.
- Other duties as assigned.

REQUIRED KNOWLEDGE, SKILLS & ABILITIES

- Demonstrates thorough knowledge of the principles and practices of civil engineering as applied to the design, construction, and maintenance of local government development projects and services.
- Knowledge of Master Municipal Construction Documents (MMCD) is preferred.

- Knowledge of WorkSafe BC regulations and relevant occupational health and safety practices and experience ensuring safe construction projects is preferred.
- Possesses excellent interpersonal and communication skills and ability to deal with people in a professional manner, especially in challenging circumstances.
