## BYLAW NO. 2500, 2017

---

A bylaw to adopt an Official Community Plan for the District of Squamish

---

**WHEREAS** under the provisions of the Local Government Act, a local government may adopt an Official Community Plan; and

**WHEREAS** the District of Squamish Council desires to adopt a new Official Community Plan including objectives and policies that will guide planning and land use decisions, respecting the purposes of local government;

**NOW THEREFORE** the Council of the District of Squamish, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as “District of Squamish Official Community Plan, Bylaw 2500, 2017”.
2. This Bylaw is applicable to all land within the municipal boundary shown on Schedule B.
3. If any section, subsection or clause of this bylaw is for any reason held to be invalid by the decision of a court of competent jurisdiction, such decision will not affect the validity of the remaining portions of this Bylaw.
4. The following bylaw and all its schedules and amendments are repealed:  
“District of Squamish Official Community Plan Bylaw 2100, 2009”.
