- > The permit holder must provide and install a Reduced Pressure Backflow Assembly (RPBA).
- A copy of the backflow test certificate, no older than one year, is required at the time of application and must be present on-site. Test certificate presented MUST match backflow unit installed.
- > Only Fire Hydrant Wrenches are to be used. DO NOT use pipe wrench.
- > This permit is for the above-mentioned Location, Hydrant Number, Date(s) only.
- > The permit holder is responsible for the de-chlorination of all water discharged to creeks, rivers, and the storm sewer system and is responsible for obtaining permits necessary from the Ministry of Environment when discharging water to sensitive areas.
- Repair costs will be charged to the applicant if the fire hydrant is damaged during the operation of this permit. District staff to inspect and test the hydrant following the applicant's use.
- > The District is not responsible for any property damage or public damage during the use of this permit.
- > Hydrant Use cannot start before District staff have installed the PERMIT tag on the hydrant.
- > The District reserves the right to revoke this work permit should the permittee fail to comply with these conditions.
